## Use and retention of data

If you are interested in a product or service of Hoek en Blok, we will (among other things) ask for your name, email address and telephone number. We will use these details to provide you with information about our service provision and/or products and to be able to perform an agreement. When you send us an email or other messages, they will be included in our email archive and stored in accordance with the statutory retention obligation.

Sometimes, we ask for personal data that are relevant to the situation in question. This will enable us to process your questions and respond to your requests.

#### Purpose

Hoek en Blok processes your personal data for the following purposes:

- to be able to call/email/write to you if such is required in the execution of our service provision;
- to inform you about changes in legislation and service provision;
- for sending our newsletters and mailings and the Hoek en Blok Schrift;
- to be able to perform an agreement;
- if Hoek en Blok has a legal obligation to do so (for example the personal data for a tax declaration, wage administration or absence supervision).

## Surveillance cameras

Hoek en Blok uses surveillance cameras at its premises, both around and at the entrances of its buildings. Hoek en Blok processes your personal data for the following purposes:

- Ensuring the safety and health of individuals;
- Securing the premises and buildings to prevent burglary, theft, and vandalism;
- Monitoring items and information within the buildings;
- Recording incidents.



## Period of time

Hoek en Blok will not retain your data any longer than strictly necessary for fulfilling the purposes for which your data are collected. Insofar as there is an administrative and/or statutory retention obligation, we will retain your data during that period of time.

## Sharing

Hoek en Blok will not sell your data to third parties. They will only disclose your data (to, for example, the Tax Authority, the health and safety service or pension fund) if such is required in the performance of our agreement with you or to comply with a statutory obligation. We conclude a processor agreement with organizations and/or companies that process your data on our instructions. Such agreements will guarantee the same level of security and confidentiality of your data.

#### Access, correction, removal

Insofar as we have collected your data on the basis of a permission granted by you, you have the right to withdraw the permission you granted. This does not compromise the legitimacy of the processing based on your permission prior to the moment of withdrawal.

#### Security

Hoek en Blok takes the protection of your data seriously and takes appropriate – security - measures, both organisational and technical, to counteract abuse, loss, unwanted disclosure and impermissible alteration of and/or unauthorized access to your personal data.
